REQUESTING THE HONORABLE PROSPERO A. PICHAY, CHAIRMAN, BOARD OF TRUSTEES, LOCAL WATERWORKS AND UTILITIES ADMINISTRATION (LWUA), KATIPUNAN ROAD, BALARA, QUEZON CITY THAT THE 90% OF THE TWENTY FIVE MILLION PESOS (PHP25M) FINANCIAL ASSISTANCE TO THE BULALACAO WATER DISTRICT, BULALACAO, ORIENTAL MINDORO BE GIVEN AS GRANTS WHILE THE REMAINING 10% BE CONSIDERED AS A SOFT OR LONG TERM LOAN OF THE WATER DISTRICT

"WHEREAS, the creation of the Bulalacao Water District in the Municipality of Bulalacao, Province of Oriental Mindoro is believed to be the best remedy to the long-time clamor of the scarcity of water particularly during summer season which brought inconvenience and difficulties to household activities added to the impediment of other industrial and commercial works;


"WHEREAS, aware of the fact that the Municipality of Bulalacao is a Pro-Poor Municipality pursuant to Executive Order No. 370 and considering that the Bulalacao Water District is in its initial stage, the allocation of the Twenty Five Million Pesos (Php25M) by the LWUA shall be of great help especially if the 90% of it be released as grants while the remaining 10% be given as a soft or long term loan of the Water District;

"WHEREAS, the creation and implementation of the Bulalacao Water District would truly uplift the social and economic status of this Third Class Municipality and its people; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Honorable Prospero A. Pichay, Chairman, Board of Trustees, Local Waterworks and Utilities Administration (LWUA), Katipunan Road, Balara, Quezon City that the 90% of the Twenty Five Million Pesos (Php25M) financial assistance to the Bulalacao Water District, Bulalacao, Oriental Mindoro be given as Grants while the remaining 10% be considered as a soft or long term loan of the Water District;




