**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2
SERIES 2020, SUPPLEMENTAL BUDGET NO. 1 FOR FY 2020 OF
BARANGAY SAN FRANCISCO, BULALACAO, ORIENTAL MINDORO
APPROPRIATING THE AMOUNT OF ONE HUNDRED TWENTY
THOUSAND PESOS (PHP120,000.00) OPERATIVE IN ITS ENTIRETY**

“WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;
