RESOLUTION REQUESTING LAND TRANSPORTATION OFFICE (LTO) THRU ITS EXTENSION OFFICE IN ROXAS, ORIENTAL MINDORO TO CONDUCT SEMINAR ON TRAFFIC RULES AND REGULATIONS AND FOR POSSIBLE DEPUTATION OF 2 PERMANENT TRAFFIC ENFORCERS AND 2 JOB ORDER TRAFFIC ENFORCERS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Land Transportation Office (LTO) is a sectoral agency of the Department of Transportation (DOTr) by virtue of Executive Order No. 125 and 125A dated April 13, 1987 and Executive Order No. 226 dated July 25, 1987, tasked to register motor vehicles, issue driver's/conductor's licenses and permits, enforce transportation laws, rules and regulations and adjudicate apprehension cases;

"WHEREAS, the Municipality of Bulalacao is on the borderline to being an agro-eco-tourism destination in the Province of Oriental Mindoro that collaborative hard works from both private and government sectors are applied and gathered together to deliver positive outcome;

"WHEREAS, Bulalacao is well-nigh to having all its roadways concrete and accessible, hence the population of the vehicles are continuously increasing and in order to maintain tranquil and orderly traffic flow it is profitable to provide trainings and seminars on traffic rules and regulations that will be useful for the intended deputation of 2 permanent traffic enforcers and 2 job order traffic enforcers in the Municipality;
