**"WHEREAS,** river restoration and rehabilitation embraces a great variety of measures on natural functions of rivers which may have been lost or degraded by human interventions such as damming, construction of levees and embankments, sediment dredging, changing of natural forms of rivers, construction of infrastructures and other types of river disturbances;

**"WHEREAS,** river restoration is also important in order to mitigate against the effects of climate change to maintain its capability to hold water both during rainy and drought seasons;

**"WHEREAS,** this is the problem faced by Upper Cawacat River situated in Barangay Cambunang, Bulalacao which made this Sanggunian seek assistance from the Provincial Government for its immediate rehabilitation taking into consideration that both sides of the river is a vast agricultural area which would directly benefit out of this. During heavy rain the rice fields experience flood and during drought the rice fields become dry;

"WHEREAS, it is heartwarming experience and a great feeling of joy that Governor "Bonz" Dolor immediately extended assistance to the Municipality of Bulalacao by sending a bulldozer to be used for the rehabilitation of the river together with the operator and expenses incur during the operation to which his kindness and benevolence truly deserves appreciation, **Now, therefore, be it**


