RESOLUTION NO. 21-06-204

RESOLUTION EXPRESSING DEEPEST SYMPATHY AND CONDOLENCES OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO TO THE BEREAVED FAMILY OF THE LATE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, BENIGNO SIMEON "NOYNOY" C. AQUINO III

"WHEREAS, that morning of June 24, 2021 foredoomed to be the last day of the former President Benigno Simeon "Noynoy" C. Aquino III as he departed to death and reunited with our Almighty God which caused distress and woebegone to his family, friends, supporters and the nation as a whole;

"WHEREAS, PNoy, as he was most knowingly called by the many, was a successful and respectful politician who served as the 15th President of the Republic of the Philippines from the year 2010 to 2016, he was first became a Member of the House of Representatives and Senate from 1998 to 2010, and also serves the Deputy Speaker of the House of Representatives from 2004 to 2006;

"WHEREAS, PNoy kept to his promise to transform our government from one that is self-serving to one that works for the welfare of the nation, and held to his foremost duty to lift the nation from poverty through honest and effective governance, it is notable that in his presidency our economic status improved from 1.1% GDP growth in 2009 to 5.8% GDP growth in 2015 and that our employment status had increased from 92.9% in 2009 to 93.7% in 2015, also our country ranked 47th out of 186 countries in the 2015-2016 World Economic Forum Global Competitiveness Report;

"WHEREAS, PNoy, was a warrior of hope and courage as he fought enormously to serious health conditions, but this battle has ended as he suffered to renal disease secondary to diabetes and died at the age of 61 years old;

"WHEREAS, the Local Government Unit and the people of the Municipality of Bulalacao appreciate and very thankful to all the infrastructure projects, livelihood programs and for all the support and excellent governance of PNoy to our country; it is remarkable that during his administration the Municipality of Bulalacao, Province of Oriental Mindoro received so much projects such as the PAMANA Project, that concreted several farm-to-market roads, the MAKAMASANG TUGON Project that constructed classrooms and other infrastructure buildings, the Sitios Electrification Program, and the construction of the RORO Port in Barangay Poblacion which connects Bulalacao to the famous Boracay Island;

"WHEREAS, with this expression of heartfelt sympathy and condolences, the Local Government of Bulalacao, Oriental Mindoro joins the bereaved family in beseeching the Almighty God the Father in His wisdom and compassion to grant eternal repose of the former President Benigno Simeon "Noynoy" C. Aquino III's soul in His glorious kingdom;
