## RESOLUTION NO. 21-11-345

**RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO PROVIDE TECHNICAL ASSISTANCE ON THE COMPREHENSIVE FLOOD CONTROL AND MITIGATION PLAN OF CORING-OT, CAVILLAN, CAWACAT, KABURAYAN AND MAUJAO RIVERS INCLUDING THEIR TRIBUTARIES, ALL IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall promote health and safety;

**"WHEREAS**, Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro, has 15 barangays 8 of which are coastal barangays, and has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**"WHEREAS**, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;

**"WHEREAS**, the Local Government of Bulalacao is hoping to have a comprehensive flood control and mitigation plan for various rivers in the municipality, thus it is needing for technical assistance that can help in making this project completed and more efficient to people; Now, therefore, be it...


