RESOLUTION NO. 21-11-353

EARNESTLY REQUESTING PRESIDENT RODRIGO ROA DUTERTE OF THE REPUBLIC OF THE PHILIPPINES TO EXTEND LEGAL ASSISTANCE FOR IMMEDIATE RESOLUTION OF PENDING CASES OF REBEL RETURNEES WHO ARE RESIDENTS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AND FURTHER REQUESTING TO INCLUDE THE DEPARTMENT OF JUSTICE AS MEMBER OF THE INTER-AGENCY TASK FORCE

“WHEREAS, on April 3, 2018, President Rodrigo Duterte signed Administrative Order No. 10 entitled “Centralizing all government efforts for the reintegration of former rebels and creating for the purpose an Inter-Agency Task Force”;

“WHEREAS, pursuant to A.O 10, the Inter-Agency Task Force for the reintegration of FRs (Former Rebels) to be known as Task Force Balik-Loob is hereby created and is composed of a representatives with a rank not lower than Undersecretary from the Department of National Defense (DND), Department of Interior and Local Government (DILG), Office of the Presidential Adviser on the Peace Process (OPAPP), Office of the President (OP) and the National Housing Authority (NHA). The Task Force shall be chaired by the DND representative who may invite such other government agencies or instrumentalities to the Task Force as he may deem necessary;

“WHEREAS, Section 1 of the same law mentioned above is Enhancement of the Comprehensive Local Integration Program (CLIP). To attain the objectives of A.O 10, the CLIP is hereby enhanced (hereinafter, E-CLIP) by providing a complete package of assistance to former rebels who were members of the Communist Party of the Philippines (CPP), New Peoples Army (NPA) and National Democratic Front (NDF) as well as their immediate

family members who have surfaced beginning on the date of the effectivity of their order and expressed their desire to abandon armed struggle and become productive members of society. All FRs who surfaced starting 1 July 2016 shall likewise be provided benefits from the E-CLIP in addition to the CLIP package that they received;

"WHEREAS, because of the comprehensive programs of the government on rebel returnees, members of the CPP, NPA and NDF in the Municipality of Bulalacao, Province of Oriental Mindoro surrendered themselves and started to live a normal life with their families however, a few of them suffered injustice such as the case of Martin Cobus, Ernesto Panganiban and another RR named Santiago who were captured by military men and put into jail by a crime of murder which they denied saying that since the day they surrendered they live peacefully with their families;

"WHEREAS, to sustain the program of Balik-Loob and to regain the trust and confidence of rebel returnees and their families, cases mentioned above should be given proper attention and resolution; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request President Rodrigo Roa Duterte of the Republic of the Philippines to extend legal assistance for immediate resolution of pending cases of rebel returnees who are residents of the Municipality of Bulalacao, Province of Oriental Mindoro and further requesting to include the Department of Justice as member of the Inter-Agency Task Force;
