RESOLUTION NO. 21-11-370

RESOLUTION INSTRUCTING ALL OFFICES OF THE LOCAL GOVERNMENT OF BULALACAO AND ENCOURAGING THE SANGGUNIANG BARANGAYS AND ALL OTHER GOVERNMENT OFFICES IN BULALACAO TO ALLOCATE AT LEAST 1/2 OF THE GENDER AND DEVELOPMENT (GAD) BUDGET IN ACTIVITIES THAT ADDRESSES THE ISSUE OF TEENAGE PREGNANCY AND PRE-MARITAL SEX

WHEREAS, Executive Order No. 141, series of 2021 declared that the State shall mobilize existing coordinative and legal mechanisms related to the prevention of adolescent pregnancies, and to strengthen the adolescent's capacity to make autonomous and informed decisions about their reproductive and sexual health by ensuring access to comprehensive sexuality education and reproductive health and rights services;

WHEREAS, the GAD budget is the cost of implementing each activity indicated in the GAD plan, it may be drawn from the agency's MOOE, CO, and PS based on the agency's approved GAA; also it shall form part of, and is not in addition to Posts and Offices' approved budget, as provided in the Magna Carta of Women, "the cost of implementing GAD programs shall be at least five percent (5%) of the agency's total budget appropriations;

WHEREAS, according to the data from the Civil Registration and Vital Statistics System of the Philippine Statistics Authority, the Philippines has recorded a total of 180,916 live births among adolescents aged 10 to 19 in the year 2019, henceforth as of June 2021 the Municipality of Bulalacao, Province of Oriental Mindoro listed 83 cases of teenage pregnancy which considered as a huge increase from the records of previous years;

"WHEREAS, based on studies, one major reason of poverty is teenage pregnancy, thus being the primary connoisseur of this issue, it is imperative for all government offices to initiate and advocate such activities that can help prevent and stop its alarming increase of cases; Now, therefore, be it...


RESOLVED AS IT IS HEREBY RESOLVED To: Instruct all offices of the Local Government of Bulalacao and encouraging the Sangguniang Barangays and all other government offices in Bulalacao to allocate at least ½ of the Gender and Development (GAD) budget in activities that addresses the issue of teenage pregnancy and pre-marital sex,






