**"WHEREAS**, Section 2 of Republic Act No. 7648 also known as the Electric Power Crisis Act of 1993 declares that it is hereby the policy of the State to adopt adequate and effective measures to address the electric power crisis that has disrupted the country's economic and social life and assumed the nature and magnitude of a public calamity;

**"WHEREAS**, for quite a long time, the Province of Oriental Mindoro has been experiencing rotational brownouts due to shortage of power supply, there has been persistent weekly schedule of power interruptions in its 14 municipalities including its sole city which is the Calapan City;

**"WHEREAS**, this caused too much inconvenience and bothersome to residents and local economy particularly those in food business, personal care services and small-to-medium enterprises that need electricity to operate and serve;


