RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ERNILO C. VILLAS REPRESENTING THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (DICT) AND FOR THE UPGRADING TO DICT'S INTEGRATED BUSINESS PERMIT AND LICENSING SYSTEM (eBPLS)

WHEREAS, the Integrated Business Permits and Licensing System (iBPLS) is being deployed by the Department of Information and Communications Technology (DICT) in collaboration with the Department of Interior and Local Government (DILG) Department of Trade and Industry (DTI) and Anti-Red Tape Authority to facilitate compliance of local government units (LGUs) to the Republic Act 11032, formally known as the *Ease of Doing Business and Efficient Government Service Delivery Act of 2018*, and its Implementing Rules and Regulations;

WHEREAS, DICT is recommending the transition/upgrading from Electronic Business Permit and Licensing System (eBPLS) into the Integrated Business Permits and Licensing System (iBPLS) with its more streamlined features;

WHEREAS, the Municipality of Bulalacao, Oriental Mindoro is one of the recipients of DICT's Electronic Business Permits and Licensing System (eBPLS);

WHEREAS, the Municipality of Bulalacao is actively implementing/utilizing the eBPLS in modernizing the processing of their business permit applications;

WHEREAS, the Local Government Unit (LGU) of Bulalacao and the Department of Information and Communications Technology (DICT) shall ensure the confidentiality and integrity of the data gathered from the public in accordance to RA No. 10173, "*An Act Protecting Individual Personal Information in Information and Communications Systems in the Government and the Private Sector, creating for this purpose a National Privacy Commission (NPC) and other purposes*" otherwise known as the "*Data Privacy Act (DPA) of 2021*" as well as the Implementing Rules and Regulations (IRR) and its issuances by the NPC;

WHEREAS, RA 8792, otherwise as the "Electronic Commerce Act of 2000" was enacted to facilitate domestic and international dealings, transactions, arrangements, agreements, contracts and exchanges and storage of information through the utilization of electronic, optical and similar medium, mode, instrumentality and technology to recognize the authenticity and reliability of electronic documents related to such activities and to promote the universal use of electronic transaction in the government and general public; **Now therefore**,


