RESOLUTION EARNESTLY REQUESTING ALL TOURISM ESTABLISHMENTS AND DESTINATION OPERATORS AND OWNERS TO ENCOURAGE EVERY TOURIST TO PLANT AT LEAST A TREE IN THE AREAS TO BE DESIGNATED BY THE OFFICE OF THE MUNICIPAL MAYOR FOR SUCH PURPOSE

“WHEREAS, reforestation aims to preserve endangered species by restoring their habitat and surprising threats to different flora and fauna species;

“WHEREAS, planting of trees is important as they improve the life and fulfill essential needs of mankind. Trees cleanse the climate by absorbing carbon dioxide from the environment and by absorbing heat from the sun;

“WHEREAS, tourism industry relies more often with natural assets and warm hospitality of the people. 
