EARNESTLY REQUESTING THE SECRETARY GENERAL, TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) TO FACILITATE THE INCLUSION OF BULALACAO TECHNICAL AND VOCATIONAL COLLEGE (BTVC) IN THE LIST OF INSTITUTIONS OPERATED BY THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) AND IN THE PROVISION OF FUNDS FOR ITS OPERATION IN THE GENERAL APPROPRIATIONS ACT OF 2020

“WHEREAS, the Technical Education and Skills Development Authority (TESDA) is a government agency tasked to manage and supervise the Philippines’ Technical Education and Skills Development (TESD). Its goals include the development of Filipino work force with world-class competence and positive works values and the provision of quality technical educational and skills development through its direction, policies and programs;

“WHEREAS, the establishment of Bulalacao Technical and Vocational College (BTVC), Bulalacao, Oriental Mindoro ten (10) years ago was made positive through the initiative of the Local Government Unit of Bulalacao in cooperation with TESDA and other government agencies with the objective of offering high school graduates who could not go to a formal college education due to financial constraints, the opportunity to learn in a career-focused environment with hands-on learning;

“WHEREAS, for ten years, BTVC has continued its operation with full support from the LGU-Bulalacao which allocates funds for wages of all its workers and staff, maintenance and other operating expenditures, and capital outlay, hence other projects could not be prioritized because of expenses entailed by the operation of BTVC;

“WHEREAS, hounded with financial difficulties, the LGU of Bulalacao is earnestly requesting TESDA to includes BTVC in the list of institutions the TESDA operates in order to sustain the noble objective of providing Bulalacaonons the chance to acquire vocational learning which is in demand here and abroad for the upliftment of the social and economic status of their families and the community in general; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Secretary General, Technical Education and Skills Development Authority (TESDA) to facilitate the inclusion of Bulalacao Technical and Vocational College (BTVC) in the list of institutions operated by the Technical Education and Skills Development Authority (TESDA) and in the provision of funds for its operation in the General Appropriations Act of 2020;




