"WHEREAS, the Department of Health issued Administrative Order No. 2016-0038 entitled "The Philippine Health Agenda" 2016-2022 which seeks to fulfill the global call for Universal Health Coverage, adopting "All for health towards Health for All" as the rallying point to realize the vision of a Healthy Philippines by 2022;

"WHEREAS, the Philippine Health Agenda (PHA) aims to ensure the best health outcome for all, without socio-economic, ethnic, gender and geographic disparities, promote health and deliver health care through means and respect, value and empower clients and patients as they interact with the health system and protect health families especially the poor, marginalized and vulnerable against the high cost of health care;
