REQUESTING THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB), REGION IV, MIMAROPA TO PROVIDE THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO WITH AN UPDATES ON THE STATUS OF TRANSPORTATION SYSTEM PLYING FROM OCCIDENTAL MINDORO TO ORIENTAL MINDORO AND WITH THE LISTS OF PRESENT FRANCHISEE AND FURTHER REQUESTING TO GRANT ADDITIONAL FRANCHISE TO QUALIFIED AND ELIGIBLE APPLICANTS FOR THE BENEFITS OF OUR COMMUTERS

"WHEREAS, public transportation improves the quality of life in communities across the country by providing safe, efficient and economical service. It also serves as a vital component necessary for a healthy economy. Not only does public transit benefit the people who use it; it also benefits society as a whole;

"WHEREAS, the Land Transportation Franchising and Regulatory Board also known as LTFRB is an agency under the Department of Transportation responsible for promulgating, administering, enforcing and monitoring compliance of policies, laws and regulations of public land transportation services including the grant of franchise to public vehicles operating within a certain routes;

"WHEREAS, the riding public from Occidental and Oriental Mindoro were surprised by the abrupt order to stop the operation of vans and buses plying between the two (2) provinces for reasons not clearly presented and explained that this situation brought difficulties and inconvenience to the commuters doing daily activities such as going to work, school and those who are engaged in small business;


"WHEREAS, this Sanggunian believed that the situation mentioned above could only be resolved by the LTFRB and nothing more; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED To: Request the Land Transportation Franchising and Regulatory Board (LTFRB), Region IV, MIMAROPA to provide the Municipality of Bulalacao, Oriental Mindoro with an updates on the status of transportation system plying from Occidental Mindoro to Oriental Mindoro and with the lists of present franchisee and further requesting to grant additional franchise to qualified and eligible applicants for the benefits of our commuters;






