RESOLUTION NO. 20-02-195

**RESOLUTION EXTENDING THE DATE ON WHICH TO IMPOSE PENALTY ON
DELAYED PAYMENT OF BUSINESS TAX UNTIL MARCH 31, 2020 DUE TO
DEVASTATION CAUSED BY SUPER TYPHOON URSULA**

"WHEREAS, Article B, Section 2B. 03 of the Revenue Code of Bulalacao states that "Time of Payment and Accrual of Tax. Unless otherwise specifically provided in this article, the tax imposed herein shall accrue on the first day of January of each year as regards subject then liable therefore the same may be paid in quarterly installments within the first twenty (20) days of January and each of the subsequent quarters. The Sangguniang Bayan, however, thru a Resolution, may extend the time of payment of such tax without penalty or surcharge for a justifiable reason or cause, provided, that the period of extension shall not exceed six (6) months.";

"WHEREAS, Bulalacao, Oriental Mindoro was devastated by the onslaught of Super Typhoon Ursula on December 25, 2019 and businesses and sources of income were badly, if not totally, damaged;


"WHEREAS, extending the date on which to impose penalty on delayed payment of business tax shall help businessmen and investors recover from losses because of such calamity;


NOW THEREFORE BE IT RESOLVED AS IT IS HEREBY RESOLVED to extend the date on which to impose penalty on delayed payment of business until March 31, 2020.


