RESOLUTION NO. 18-07-205

RESOLUTION REQUESTING THE BUREAU OF INTERNAL REVENUE (BIR), REVENUE DISTRICT OFFICE NO 63, CALAPAN CITY THRU MR. REX PAUL R. RECOTER, OFFICER IN CHARGE TO RECONSIDER ITS DECISION TO COLLECT 3% PERCENTAGE TAX FROM JOB ORDER AND CONTRACT OF SERVICE WORKERS OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO EARNING BELOW PHP250,000.00 ANNUALLY AS THEY COMPLY THE REQUIREMENTS FOR EXEMPTION MENTIONED IN REVENUE MEMORANDUM CIRCULAR NO. 51-2018

“WHEREAS, it is understood that the TRAIN Law exempts all self-employed individuals and professionals earning not more than Two Hundred Fifty Thousand Pesos (PhP250,000.00) annually from all taxes including percentage taxes;

“WHEREAS, the BIR confirmed the exemption mentioned above and explained that to effectively enjoy the benefit, the self-employed individuals including job order and contractual employees hired by the local government units only has to register with the BIR as self-employed, choose the 8% gross income tax option, and submit an affidavit stating that he/she is not earning more than PhP250,000.00 annually;

“WHEREAS, the exemption from such taxes for our job order and contract of service workers earning in daily basis and below minimum wage shall be of great relief and consolation for them-a significant assistance which will help them meet both ends; **Now, therefore, be it**


RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Bureau of Internal Revenue (BIR), Revenue District Office No. 63, Calapan City thru Mr. Rex Paul R. Recoter, Officer In Charge to reconsider its decision to collect 3% percentage tax from job order and contract of service workers of the Local Government Unit of Bulalacao, Oriental Mindoro earning below PhP250,000.00 annually as they comply the requirements for exemption mentioned in Revenue Memorandum Circular No. 51-2018;




