"WHEREAS, Bulalacao, Oriental Mindoro is well-nigh to being an eco-agro-tourism destination in MIMAROPA Region, has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;
