RESOLUTION NO. 19-01-020

RESOLUTION REQUESTING THE SANGGUNIANG PANLALAWIGAN OF ORIENTAL MINDORO TO RECONSIDER ITS REVIEW ON MUNICIPAL ORDINANCE NO. 18-09-215 ENTITLED “AN ORDINANCE CREATING THE POSITIONS OF SEVEN (7) ADMINISTRATIVE AIDE I IN THE PLANTILLA OF POSITIONS OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO AND APPROPRIATING FUNDS FOR SUCH PURPOSE”

“**WHEREAS**, in the interest of public service and for the effective and efficient local bureaucracy, seven (7) Administrative Aide I positions were created pursuant to Municipal Ordinance No. 18-09-215 dated September 21, 2018;

“**WHEREAS**, upon review of the Sangguniang Panlalawigan on the subject ordinance, it was declared inoperative in its entirety for reasons mentioned in SP Resolution No. 4492-2018 dated December 17, 2018;

“**WHEREAS**, based on our records, the funding requirement for the seven (7) Administrative Aide I positions was duly appropriated in Supplemental Budget No. 2 under Appropriation Ordinance No. 18-09-10 dated September 21, 2018 and included in the Annual Budget FY 2019; the second tranche of Salary Standardization was fully funded under Supplemental Budget No. 1, FY 2018 and the third tranche was fully funded for implementation in the Annual Budget FY 2019;

“**WHEREAS**, the fund appropriated for such positions under Appropriation Ordinance No. 18-09-10 and 2019 Annual Budget based on Section 2 of Municipal Ordinance No. 18-09-215 which states that “**The fund needed for these positions shall be appropriated thru Supplemental Budget during the present fiscal year and shall be included in the**

appropriations for 2019 and years thereafter. The Municipal Budget Officer shall ensure that the budget necessary for the implementation of this Ordinance shall be properly and adequately appropriated. The fund appropriated and allocated for this purpose shall not be allowed for realignment and not be certified as savings unless it served its purpose already within a particular fiscal year”;

“WHEREAS, because the positions were fully funded in Supplemental Budget No. 2 and 2019 Annual Budget in compliance with Section 2 of Municipal Ordinance No. 18-09-215, it is never fair to state that there is no real need for the created positions;

“WHEREAS, the plantilla of positions of the Local Government Unit of Bulalacao shows that all mandatory positions required by R.A. 7160 and all other laws have already been created;

“WHEREAS, based on the explanations mentioned above, it is hereby requested that the review of the Sangguniang Panlalawigan on Municipal Ordinance No. 18-09-215 be reconsidered and subsequently be declared operative in its entirety; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED To: Request the Sangguniang Panlalawigan of Oriental Mindoro to reconsider its review on Municipal Ordinance No. 18-09-215 entitled “An ordinance creating the positions of seven (7) Administrative Aide I in the plantilla of positions of the Local Government Unit of Bulalacao, Oriental Mindoro and appropriating funds for such purpose”;
