**"WHEREAS**, pursuant to Article XIV, Section 2, Paragraph 1 of the 1987 Philippine Constitution which states that "the State shall establish, maintain and support a complete, adequate and integrated system of education relevant to the needs of the people and society," and paragraph 4 which "encourages non-formal, informal and indigenous learning systems as well as self-learning, independent and out-of-school study programs particularly those that respond to community needs";

**"WHEREAS**, Alternative Learning System (ALS) extends beyond traditional classroom-based learning because it is anchored on building life skills, enhancing tech-vocational capacities and skill-based training for its learners to improve their quality of life and to ensure their work readiness or employability upon completion of the program;

"WHEREAS, the Local Government Unit of Bulalacao, Oriental Mindoro has been a dynamic partner of Department of Education in providing quality and inclusive education and access to it, such as alternative means of learning to those who are unable to avail a formal learning and those who dropped out of their formal education;


"WHEREAS, this Sanggunian believes the time-honored doctrine that education is life, inalienable and a right that must be enjoyed by all, thus, it is an immense and rare privilege to rekindle the hope of these underserved people who were forced to stop schooling because of economic constraint, thus, providing them a learning hub is a great help; Now, therefore, be it...
