AN ORDINANCE AMENDING SECTION 33 OF RESOLUTION NO. 27 ORDINANCE NO. 10 SERIES OF 1974.

BE IT Ordained by the Sangguniang Bayan of Bulalacao.

T h a t

SECTION 1. PERMIT FEES. There shall be paid to the Municipal Treasurer for every permit issued by the Mayor for the business, trade, occupation or privileges herein below enumerated as in this Ordinance provided, an annual fixed fee in accordance with the following rates.

SECTION 2. Mayor's Shipping Permit - There shall be paid to the Municipal Treasurer for every shipment of grains, large cattle or other minor animals in accordance with the following rates:

a) <u>Shippers of grains per shipment:</u>	
Less than 200 cavans of palay, rice, corn, etc...	20.00
200 or more but less than 300	30.00
300 or more but less than 500	50.00
500 or more but less than 700	70.00
700 or more but less than 1,000	100.00
For every 50 cavans in excess of 1,000	20.00
b) <u>Shippers of large cattle of other minor animals, per shipment:</u>	
For private consumption	5.00
For agricultural purposes	5.00
For commercial purposes	15.00
Less than 10 heads of large cattle	10.00
Less than 10 heads of minor animals	20.00
10 or more but less than 30 heads, minor animals	30.00
10 or more but less than 30 heads, large animals	40.00
30 or more but less than 50 heads, minor animals	60.00

SECTION 3. Violation of any provisions of this Ordinance or part thereof, shall be punished by fine of not less than FIFTY (P50.00) but not more than TWO HUNDRED (200.00) PESOS or shall be imprisoned for not less than (5) days or more than THIRTY (30) days, or both at the court.

SECTION 4. Any Ordinances in conflict or inconsistent with the provisions of this Ordinance shall be null and void.


SECTION 5. WHEN TO TAKE EFFECT: This Ordinance shall take effect after FIFTEEN (15) days of its passage.

RESOLVED, FURTHER, that copies of this Ordinance be furnished the Provincial Treasurer, Calapan, Oriental Mindoro for review and approval.
