RESOLUTION NO. 48

RESOLUTION REQUESTING THE HON. THE SECRETARY OF AGRICULTURE AND
NATURAL RESOURCES, MANILA, THRU THE PROVINCIAL BOARD OF ORIENTAL
MINDORO, TO CANCEL, REVOKE AND TERMINATE THE LEASE CONTRACT BET-
WEEN THE MUNICIPALITY OF SAN PEDRO, REPRESENTED IN THE INSTANT
CASE, BY THE MUNICIPAL MAYOR AND IDELFONSO KAJAYON OF THE PARTY
OF THE SECOND PART:

WHEREAS, by certain public instrument made and entered at San
Pedro, Oriental Mindoro on the 27th day of February 1969, before
Angel C. Contreras a Notary Public in and for the Municipality of
San Pedro, Oriental Mindoro and registered under Doc. No. 8; Page
No. 16; Book No. 111 and Series of 1969 of the Registry of said
Notary, did, make execute lease contract for a period of three (3)
years from February 27, 1969 to February 27, 1972, the exclusive
privilege of catching Bangus Fry throughout and within the juris-
diction of the Municipality of San Pedro, Oriental Mindoro;

WHEREAS, this body, the Municipal Council of San Pedro, Oriental
Mindoro thru the Mayor, desire to terminate the said lease contract
for failure to file bond and to pay the remaining amount as stipulated
in the contract;

On motion of Councilor Modesto Becawag and duly seconded by Vice-
Mayor Dolores S. Rigo, be it

RESOLVED, by this body, the Municipal Council of San Pedro, Or-
iental Mindoro, to request the Hon. the Secretary of Agriculture and
Natural Resources, Manila, thru the Provincial Board of Oriental
Mindoro, to cancel, revoke, terminate the said written lease contract
for catching Bangus Fry between the Municipality of San Pedro and Mr.
Idelfonso Kajayon for non-wilfull payment of the remaining amount
and to file bond when due as called forth in the lease contract.
