SPECIAL ORDINANCE NO. 08-06-85

TEMPORARILY CLOSING TEMPLANZA, CONTRERAS AND PANTILO STREETS AT POBLACION, BULALACAO, ORIENTAL MINDORO FOR PURPOSES OF FIESTA CELEBRATIONS OF THIS MUNICIPALITY

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.

SECTION 1. In order to accommodate the selling of goods, merchandise, foodstuffs, commodities or any articles of commerce to the general public during the town fiesta celebration of this Municipality on June 28-29, 2008, Templanza, Contreras and Pantilo Streets at Poblacion, Bulalacao, Oriental Mindoro are hereby temporarily closed effective June 27, 2008; Provided that said temporary closure shall not exceed the period of nine (9) days pursuant to Article 45 of the Implementing Rules and Regulations of RA7160 otherwise known as the Local Government Code of 1991;
