

ORDINANCE NO. 4

AN ORDINANCE PROHIBITING ANY PERSON OR PERSONS NATURAL OR JURIDICAL TO TIE, LOOSE, OR GRAZE, ANY KINDS OF ANIMALS SUCH AS: CARABAOS, COWS, HORSES, GOATS, PIGS, AND OTHERS INSIDE THE CAMPUS OF THE CENTRAL SCHOOL AND BARANGAY SCHOOLS WITHIN THE JURISDICTION OF THE MUNICIPALITY OF BULALACAO ORIENTAL MINDORO AND SHALL PROVIDE FINES AND PUNISHMENT FOR EVERY VIOLATION HEREOF.

WHEREAS, different kinds of animals are being tied, loosen or grazed inside the Campus of the Central School and Barangay Schools of Bulalacao Oriental Mindoro;

WHEREAS, plants belonging to the school children were damaged by said animals;

WHEREAS, the school authorities prohibits the tying, loosening and grazing any kinds of animals inside the Campus of the Central School and Barangay Schools yet, owners of the same continued to do it;

NOW, THEREFORE, the Sangguniang Bayan of Bulalacao, hereby Ordains,

T h a t

SECTION 1. All person or persons natural or juridical are strictly prohibited to tie, loose, or graze any kind of animals, such as : Carabaos Cows, horses, pigs, and others inside the Campus of the Central School and Barangay School within the jurisdiction of the Municipality of Bulalacao, Oriental Mindoro;

SECTION 2. Animals or animals found by the school authorities inside the Central School Campus mentioned in Section 1 hereof, shall be brought to the Municipal pound to be impounded and dispose in accordance with Municipal Ordinance No. 1, Series of 1978. In the case of Barangay Schools, animals found by the school authorities inside the school Campus shall be brought to the Barangay Captain for, proper disposition and the owner of said animals shall be liable for any fines and punishments in accordance with the respective Barangay Ordinances pertaining thereto;

SECTION 3. Sign boards prohibiting the same shall be placed outside the school fence of the Central School and Barangay Schools respectively in order to inform the general public;


SECTION 4. Violation of this Ordinance or parts hereof shall be fined the amount of TWENTY FIVE (P25.00) PESOS or more but not exceeding FIFTY (P50.00) PESOS and an imprisonment of Five days (5) or more but not exceeding THIRTY DAYS (30) or both such fine and imprisonment at the discretion of the Court.

SECTION 5. This Ordinance shall take effect immediately upon its approval;

RESOLVED, FURTHER, that the copies of this Ordinance be furnished the Sangguniang Panlalawigan, Calapan Oriental Mindoro for review and approval.
