SPECIAL ORDINANCE NO. 08-06-79

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A CONTRACT OF LEASE WITH MR. FERDINAND D. DE ASIS, PRESIDENT AND REPRESENTING THE FEEDS SUPPLY AND AQUA CULTURE PRODUCTS (FSAP) REGARDING THE RENTALS OF A CERTAIN PORTION OF LOT CONTAINING AN AREA OF FIVE HUNDRED SQUARE METERS (500 SQ. M) LOCATED WITHIN THE SITE OF THE EXISTING MUNICIPAL FISH LANDING PORT AT SITIO KAW-AYAN, POBLACION, BULALACAO, ORIENTAL MINDORO
