SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE NASSER C. PANGANDAMAN, SECRETARY, DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE GRANT OF TEN MILLION PESOS (PHP10M) OF THE LATTER TO THE FORMER TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF BARANGAY BAGONG SIKAT PROPER-SITIO CAMBAYANG, BARANGAY CABUGAO-BOUNDARY OF OCCIDENTAL MINDORO FARM TO MARKET ROAD, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, Engr. Ernito C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Honorable Nasser C. Pangandaman, Secretary, Department of Agrarian Reform (DAR) for the grant of Ten Million Pesos (Php10M) of the latter to the former to be used for the construction/rehabilitation of Barangay Bagong Sikat Proper-Sitio Cambayang, Barangay Cabugao-Boundary of Occidental Mindoro Farm to Market Road, all of the Municipality of Bulalacao, Province of Oriental Mindoro.

SEC. 2. This special ordinance shall take effect immediately.
