VILLAS WITH TABOK SMALL FISHPOND OPERATORS ASSOCIATION REPRESENTED BY MR. REMANDO B. ALEJANDRO FOR THE GRANT OF EXCLUSIVE FISHERY RIGHTS OF THE FORMER TO THE LATTER IN VIEW OF THE TWO (2) CONSECUTIVE FAILED BIDDINGS THEREOF**
