ORDINANCE NO. 03-05-032

**DECLARING ASLOM, SILAD, TARGET AND SOGUICAY ISLANDS
AS MARINE PROTECTED AREAS IN THE MUNICIPALITY OF
BULALACAO, PROVINCE OF ORIENTAL MINDORO
PROHIBITING THE USE OF ACTIVE FISHING GEAR AND AMONG
OTHERS.**

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental
Mindoro:

SECTION 1. POLICY:

It is hereby declared as a policy to achieve food security as the overriding consideration in the utilization, management, development, conservation and protection of fishery resources in order to provide the food needs of the population and; To limit access to the fishery and aquatic resources of the municipal waters for the exclusive use and enjoyment of Bulalacao bonafide residents. A flexible policy towards the attainment of food security shall be adopted in response the changes in demographic trends for fish, emerging trends in the trade of fish and other aquatic products in domestic and international markets, and the law of supply and demand.

SEC. 2. SCOPE OF APPLICATION.

This Ordinance shall apply to the municipal waters surrounding the islands of Silad, Aslom, Targets and Soguicay including all bays and other fishery management and marine protected areas.

SEC. 3. REGULATED ACTS.

It shall be unlawful to engage in fishing in municipal waters and in all bays as well as other fishery management and marine protected areas using active fishing gear as defined under Section 4 par 40 (a) ^{OR PA 8550} as an active fishing gear characterized by gear movements, and/or the pursuit of the target species by towing, lifting, and pushing the gears, surrounding, covering dredging, pumping and scaring the target species to impoundments; such as, but not limited to, trawl, purse seines, Danish seines, bag nets, paaling, drift gill net and tuna longline; Provided, however, that passive fishing gear which is characterized by the absence of gear movements and/or the pursuit of the target species; such as but not limited to, hook and line, fishpots, traps and gill nets across the path of the fish.

SEC. 4. PENALTY CLAUSE.

Any violation of the above provision shall suffer the penalty of six (6) months imprisonment or fine of Two thousand five hundred pesos (Php2,500.00) or both such fine and imprisonment at the discretion of the Court.

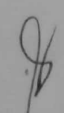
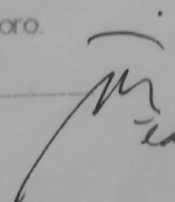
SEC. 5. REPEALING CLAUSE.

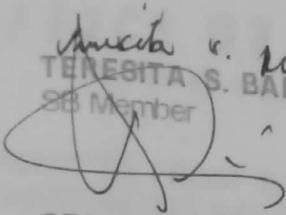
All ordinances, Executive Orders and rules and regulations which are inconsistent hereof are hereby repealed or modified accordingly.

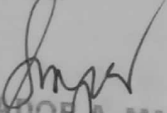
SEC. 6. EFFECTIVITY.

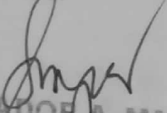
This Ordinance shall take effect ten (10) days after its posting.

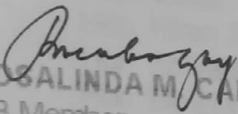
