SPECIAL ORDINANCE NO. 10-02-50

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE ARTHUR C. YAP, SECRETARY, DEPARTMENT OF AGRICULTURE (DA) FOR GRANTING THE AMOUNT OF FIVE MILLION PESOS (PHP5M) TO THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF FARM TO MARKET ROAD FROM SITIO SAN MIGUEL NATIONAL HIGHWAY TO RECODO, ALL OF BARANGAY MAUJAO, THIS MUNICIPALITY AND RATIFYING THE SAME CONTRACT

Yap, Secretary, Department of Agriculture (DA) for granting the amount of Five Million Pesos (Php5M) to the Municipality of Bulalacao, Oriental Mindoro to be used for the construction/rehabilitation of Farm to Market Road from Sitio San Miguel National Highway to Recodo, all of Barangay Maujao; and to ratify the same contract;


