SPECIAL ORDINANCE NO. 10-01-02

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO NEGOTIATE AND ENTER INTO A LOAN AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES, PINAMALAYAN BRANCH, PINAMALAYAN, ORIENTAL MINDORO IN THE AMOUNT OF TWO MILLION EIGHT HUNDRED THOUSAND PESOS (PHP2.8M) TO BE USED FOR THE IMPLEMENTATION OF CERTAIN PROGRAMS
