**SPECIAL ORDINANCE NO. 15-02-04**

**SPECIAL ORDINANCE DESIGNATING THE MUNICIPAL MAYOR, THE MUNICIPAL ACCOUNTANT AND THE IN-CHARGE OF OFFICE-MUNICIPAL TREASURER TO BE THE SIGNATORIES IN THE ELECTRONIC FILING AND PAYMENT SYSTEM (eFPS) WHICH IS ONE OF THE E-SERVICES OF THE BUREAU OF INTERNAL REVENUE WHICH ALLOW THE TAXPAYERS TO A PAPERLESS TAX FILING AND CONVENIENT PAYMENT OF TAX DUES UTILIZING THE INTERNET FACILITY**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The Honorable Edna C. Villas, Municipal Mayor, Mr. Romeo O. Fallaria, Municipal Accountant and Ms. Ederlinda T. Gonzales, ICO-Municipal Treasurer, all of the Municipality of Bulalacao, Province of Oriental Mindoro are hereby designated to be the signatories in the Electronic Filing and Payment System (eFPS) which is one of the e-Services of the Bureau of Internal Revenue which allow the taxpayers to a paperless tax filing and convenient payment of tax dues utilizing the internet facility;




