**SPECIAL ORDINANCE NO. 11-01-06**

**SPECIAL ORDINANCE TEMPORARILY CLOSING ATIENZA AND TEMPLANZA STREETS IN BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO**

**SPONSOR:** Councilor Ramon G. Magbanua  
**CO-SPONSOR:** Councilor Eduardo C. Acheron

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** In order to accommodate the selling of goods, merchandise, foodstuffs, commodities or articles of commerce by transient businessmen or traders to the general public in celebration of this year's town fiesta, Atienza and Templanza Streets in Poblacion, Bulalacao, Oriental Mindoro are hereby temporarily closed starting February 15, 2011 up to March 1, 2011;

**SEC. 2.** Any person violating this Ordinance shall suffer the penalty of six (6) months imprisonment or shall be fined by an amount of Two Thousand Five Hundred Pesos (Php2,500.00) or both such fine and imprisonment at the discretion of the Court;




**SEC. 3.** This Special Ordinance shall take effect immediately.


