SPECIAL ORDINANCE CLASSIFYING AND DECLARING THE ROAD TRAVERSING CROSSING CAWACAT-TAFARMA-SAN JUAN-BANGKAL TO SAN ROQUE CROSSING SITUATED IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AS PROVINCIAL ROAD
