**ORDINANCE NO. 11-08-113**

**FIXING THE REVISED RATE OF WATER CONSUMPTION WITHIN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**SPONSOR:** Councilor Juan L. Salas, Sr.  
**CHAIRMAN:** Committee on Ways and Means  
**CO-SPONSOR:** Councilor Eduardo C. Aceron

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The rate of water consumption within the Municipality of Bulalacao, Province of Oriental Mindoro is hereby fixed in the following manner; to wit:

- i. Minimum rate at minimum water consumption - Php40.00/2 cu.m
- ii. For every cubic meter in excess of two (2) cubic meter - 25.00/cu.m

**SEC. 2.** The reconnection fee is likewise fixed at Three Hundred Pesos (Php300.00).

**SEC. 3.** The payment hereof shall be paid to the Municipal Treasurer or to his duly authorized representative before the expiry date to be determined in order to avoid penalties or surcharges.

**SEC. 4.** Provisions of any ordinance inconsistent hereof are hereby repealed, modified accordingly.

**SEC. 5. Penalty.** Any violation of this Ordinance shall be punished by a fine of not less than One Thousand Pesos (Php1,000.00) but not more than Two Thousand Five Hundred Pesos (Php2,500.00) or an imprisonment of not less than one (1) month but not more than six (6) months or both such fine and an imprisonment at the discretion of the Court.

**SEC. 6. Effectivity.** This Ordinance shall take effect ten (10) days after its posting.




