SPECIAL ORDINANCE NO. 12-01-05

**SPECIAL ORDINANCE GRANTING AUTHORITY TO THE MUNICIPAL
MAYOR TO ISSUE A SPECIAL PERMIT TO OPERATE A BARANGAY FLEA
MARKET, BARANGAY SAN ROQUE PROPER, BULALACAO, ORIENTAL
MINDORO DURING THURSDAY OF EVERY WEEK, AND FOR OTHER
PURPOSES**

Chairman: Committee on Ways and Means

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao,
Oriental Mindoro:

SECTION 1. The Municipal Mayor is hereby authorized to issue a Special Permit to operate a Barangay Flea Market during every Thursday of every week at Barangay San Roque Proper, this Municipality.

SEC. 2. There shall be collected a fee of Fifty Pesos (Php50.00) for every Special Mayor's Permit to conduct business trade or commercial undertaking within the area designated as Flea Market at Barangay San Roque Proper, Bulalacao, Oriental Mindoro.

SEC. 3. The permit fee imposed herein shall be paid to the Municipal Treasurer or his duly authorized representative before the business operation is made and the special mayor's permit issued.

SEC. 4. A Special Committee is hereby created composed by the Municipal Treasurer as Chairman, the Punong Barangay concerned, the Market Administrator and Chairman of SB Committee on Ways and Means as members. The Committee shall submit within 15 days draft of the implementing rules and regulations to the Sangguniang Bayan for the latter's approval.

SEC. 5. Any person found violating this Ordinance shall suffer the penalty of:


- a. First Offense - A fine of Php100.00
- b. Second Offense - A fine of Php500.00
- c. Third and succeeding offenses - A fine of Php2,500.00 or an imprisonment of thirty (30) days or both such fine and imprisonment of the discretion of the Court.


SEC. 6. All Special Ordinance inconsistent hereof are hereby repealed, modified accordingly.


SEC. 7. This Special Ordinance shall take effect ten (10) days after its posting.


