**MUNICIPAL ORDINANCE NO. 19-06-228**

**AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO EVERY HIGH SCHOOL STUDENT, COLLEGE STUDENT, AND PREPARATORY AND ELEMENTARY SCHOOL PUPIL QUALIFIED FOR SPORTS OR ACADEMIC COMPETITION IN REGIONAL, NATIONAL, AND INTERNATIONAL LEVELS**

**WHEREAS**, Article II, Section 13 of the 1987 Constitution of the Republic of the Philippines provides that "The State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being";

**WHEREAS**, the Local Government Unit of Bulalacao, Oriental Mindoro (LGU of Bulalacao) positions Bulalacao to become the center of academic excellence in the province of Oriental Mindoro and therefore supports Bulalacaonon pupils and students who excel in academic and sports competitions in regional, national, and international levels;

**WHEREAS**, the monetary assistance is a proof of the LGU of Bulalacao's sincere commitment to pursue, maintain, and sustain the Education for All Program and to actively support the children and youth in their worthy undertakings and encourage academic and sports excellence among them;

**NOW, THEREFORE, BE IT ORDAINED**, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, that:

**Section 1. Title.** This Ordinance is entitled as stated and shall be known as "The 2019 Financial Assistance for Students and Pupils Participating in Regional, National, and International Academic and Sports Competitions Ordinance of the Local Government Unit of Bulalacao, Oriental Mindoro".

**Section 2. Declaration of Policy.** It is the policy of the LGU of Bulalacao to provide assistance to students and pupils participating to regional, national, and international levels of academic and sports competitions.

**Section 3. Financial Assistance.** The following monetary assistance shall be extended to qualified students and pupils per actual day of participation or competition:

Level	Regional	National	International
Preparatory	300	400	600
Elementary	400	500	700
High School	500	600	800
College	600	700	1000

**Section 4. Rules and Regulations.** The following rules and regulations shall be observed and respected:

- a. All students and pupils participating in regional, national, and international academic and sports competitions shall be entitled to this financial assistance regardless of political interest or affiliation, religious belief, gender preference, cultural group, or educational attainment;
- b. The competitor shall submit a letter addressed to the municipal mayor stating the intent to avail the assistance. The valid school identification card and certification by the school head on the eligibility of the pupil or student to compete in regional or higher levels shall be attached to such letter;
- c. There must be no unnecessary delays in granting the assistance subject to limitations as mentioned in this Ordinance;
- d. The Municipal Budget Officer shall make sure that fund for this purpose is set aside and always available all year round;
- e. The Education Unit or its equivalent in the Office of the Municipal Mayor shall be responsible in the preparation and processing of voucher and other documents pertinent to this monetary support. It shall also take charge in all matters concerning the implementation of this Ordinance;
- f. The grant shall be subject to availability of funds and to usual accounting rules and regulations, and documents to be required by the Municipal Accounting Office shall be complied with.

**Section 5. Appropriation.** The fund needed for the implementation of this ordinance shall be included in the Annual Budget and Annual Investment Program for the fiscal year 2020 and years thereafter and shall be charged under the existing and related appropriation under Maintenance and Other Operating Expenses of the Office of the Municipal Mayor. The Municipal Budget Officer based on recommendation of Education Services Focal Person or its equivalent in the Office of the Municipal Mayor shall ensure that the budget necessary for the implementation of this Ordinance is included in yearly appropriation. The fund allocated for this purpose shall not be allowed for realignment and not be certified as savings unless it served its purpose already within a particular fiscal year.

**Section 6. Penalty.** Any officer or employee who shall disregard or neglect the implementation of this Ordinance shall be administratively dealt with and such shall be a ground for suspension or dismissal subject to the pertinent provisions of the Civil Service Laws and Rules.







**Section 7. Repealing Clause.** Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

**Section 8. Separability Clause.** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.

**Section 9. Effectivity.** This Ordinance shall take effect on January 1, 2020 provided this Ordinance should have been posted for at least fifteen (15) days in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.
