MUNICIPAL ORDINANCE NO. 20-05-263

AN ORDINANCE MANDATING THE MUNICIPAL HEALTH OFFICE TO INCLUDE IN ITS FUNCTIONS THE ACTIVITIES NECESSARY TO COLLECT OR CLAIM PAYMENTS FOR PRIMARY CARE BENEFIT, MATERNITY CARE PACKAGE, ANIMAL BITE PACKAGE, OUT-PATIENT MALARIA PACKAGE, FAMILY PLANNING PACKAGE, AND TUBERCULOSIS DIRECTLY OBSERVED TREATMENT SHORT COURSE PACKAGE OFFERED AND MADE AVAILABLE BY THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH)

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 states that "Every local government unit shall have the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare."

WHEREAS, Republic Act No. 11223 or the Universal Health Care Law ensures holistic health care for every Filipino by reorienting health care towards health promotion and preventive care, from a curative care focused system;

WHEREAS, PhilHealth offers payment packages that are aligned with health promotion and preventive care strategies such as Primary Care Benefit (PCB), Maternity Care Package, and Family Planning Package together with cure-based benefits like Animal Bite Package, Out-Patient Malaria Package, and Tuberculosis Directly Observed Treatment Short Course (TB DOTS) Package;

WHEREAS, since 2016 until the first quarter of 2020, no significant payments from PhilHealth have been added to the coffers of the LGU of Bulalacao due to the absence of employees focused on activities related to the matter, among other reasons;

WHEREAS, mandating the Municipal Health Office to attend to such activities shall clarify functions, policies, and directions and shall uphold Section 478 (c) of Republic Act 7160;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

Section 1. Short Title. This Ordinance shall be also known as the "Ordinance on Additional Mandated Functions to Municipal Health Office of Bulalacao, Oriental Mindoro".

Section 2. Mandatory Provisions. In addition to the mandated functions of the Municipal Health Officer, the following responsibilities shall be performed by the Municipal Health Officer and by the Municipal Health Office (MHO):

- a. Assigning permanent employees who shall perform works in connection with application for or renewal of license to operate and PhilHealth accreditation of services and facilities related to Primary Care Benefit (PCB), Maternity Care Package, Animal Bite Package, Out-Patient Malaria Package, Family Planning Package, and Tuberculosis Directly Observed Treatment Short Course (TB DOTS) Package;
- b. Ensuring that licenses to operate and certificates of accreditation are always updated;
- c. Coordination with the Department of Health (DOH) and PhilHealth in order to facilitate reporting, trouble shooting if necessary, and payment;
- d. Coordination with other offices of the LGU of Bulalacao pertinent to this concern;
- e. Provision of good and speedy internet connection;
- f. Informing the Local Health Board and the Municipal Mayor whenever payment has been made so that the same shall make final decision on how the proceeds shall be divided and utilized in accordance with pertinent PhilHealth and DOH issuances; and
- g. Recommending to the Municipal Mayor, the Sangguniang Bayan Office, and other authorities adjustments necessary in the discharge of herein mentioned duties.

These additional functions shall be integrated to the MHO's Office Performance Commitment and Review (OPCR) and to concerned employees' Individual Performance Commitment and Review (IPCR).

Section 3. Budget. There is hereby appropriated an amount of one thousand pesos (Php 1,000.00) for monthly internet expense under the Municipal Health Office for the fiscal year 2020 and every year thereafter. Additional budget for internet connectivity may be allocated from payments made by PhilHealth. Fund disbursement shall follow the usual budgeting, accounting, and auditing procedures.

Section 4. Administrative Provision. The Municipal Mayor being the local chief executive, through the Municipal Administrator, shall have the responsibility to monitor the compliance to this Ordinance and may issue pertinent administrative orders. The Human Resource Management Officer shall make sure that the additional mandated functions enumerated herein are properly integrated in MHO's OPCR and concerned MHO employees' IPCR.

Section 5. Penalty. Any official, officer, employee, or worker who shall disregard or neglect the implementation of this Ordinance shall be administratively dealt with and such shall be a ground for suspension or dismissal subject to the pertinent provisions of the Civil Service Laws and Rules, the Local Government Code, and other laws and policies.

Section 6. Repealing Clause. Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

Section 7. Separability Clause. If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.

Section 8. Effectivity. This Ordinance shall take effect immediately fifteen (15) days after posting of approved ordinance in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.




