MUNICIPAL ORDINANCE NO. 17-05-182

AN ORDINANCE APPROPRIATING THE FEES COLLECTED FOR THE CHANGE OF NAME AND CORRECTION OF CLERICAL ERROR BASED ON RA 9048 AS AMENDED BY RA 10172 AND DEPOSITED IN A TRUST FUND ACCOUNT TO BE USED FOR THE MAINTENANCE AND OTHER OPERATING EXPENDITURES OF THE MUNICIPAL CIVIL REGISTRY OFFICE OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

Section 1. The related provisions of Republic Act No. 10172 entitled "An Act further authorizing the City or Municipal Civil Registrar or the Consul General to correct clerical or typographical errors in the day and month in the date of birth or sex of a person appearing in the civil register without need of a judicial order, amending for this purpose Republic Act Numbered 9048" are hereby adopted.

Section 2. Section 8 of the same Act provides that the Municipal Civil Registry Office is authorized to collect reasonable fees as condition for accepting the petition and such funds shall be deposited as trust fund to be solely used by the Office for its maintenance and other operating expenditures.

Section 3. All fees collected for the change of name and correction of clerical error based on RA 9048 as amended by RA 10172 shall be deposited in a trust fund account of the agency and hereby appropriated for the maintenance and other operating expenditures of Municipal Civil Registry Office of the Local Government Unit of Bulalacao, Oriental Mindoro. Utilization of such fund shall be in accordance with the usual procurement, budgeting, accounting, disbursement, and auditing rules and regulations.

Section 4. This Ordinance shall take effect immediately.






