**"WHEREAS**, Section 34 of the Local Government Code of 1991 states that Local Government Unit shall promote the operation and establishment of people's nongovernmental organizations to become active partners in the pursuit of local autonomy;

**"WHEREAS**, the Municipality of Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro, it has a municipal government that aims to promote healthful and safe mobility of people and efficient movement of goods and services by municipal wide development;


**"WHEREAS**, *Samahan ng mga Manggagawa sa Balatasan (SAMASABALATASAN)* is an association of the local community in Barangay Balatasan, Bulalacao, Oriental Mindoro which was duly registered with Department of Labor and Employment on June 30, 2005 with only 18 pioneering members, in 2008 it started its seaweed farming under the convergence project of the Department of Agrarian Reform, Department of Agriculture-FTC and Bureau of Fisheries and Aquatic Resources MIMAROPA; henceforth, its members are developing different kinds of seaweeds that can be used in making noodles, pickles, crackers and even herbal soaps and shampoos;


"WHEREAS, SAMASABALATASAN had garnered different awards and recognitions in the provincial and regional level, not only it is a pride and honor of Bulalacao but it is also a huge contributor in providing livelihood and income for the municipality as a whole, unfortunately, it still has no service vehicle that can be used in delivering its supplies and products; Now, therefore, be it...


