WHEREAS, the Local Government Unit of Bulalacao pursuant to the provisions of Republic Act No. 11032, otherwise known as the "Ease of Doing Business and Efficient Government Service Delivery Act" is currently undertaking the modernization of its facility to provide speedy and efficient government transactions involving electronic delivery and transfer of money for products and services rendered to its clientele;

WHEREAS, the LANDBANK designed and operated LANDBANK Link Bizportal to allow partner-merchants' clients to directly transact with the LANDBANK payment gateway or allows partner-merchants to directly interface with the LANDBANK payment gateway, whichever is available;

WHEREAS, under LANDBANK Link Bizportal, LGU-Bulalacao clients may transact business and/or pay their monetary obligations to LGU-Bulalacao via the internet using any of the ePayment models being offered by LANDBANK and subject to the terms and conditions appurtenant thereto;

WHEREAS, LGU-Bulalacao agrees to enter into direct agreement with LANDBANK to avail of the ePayment models offered by LANDBANK as applicable;

WHEREAS, LANDBANK has been chosen as the solely depository and financial settlement bank for LinkBiz Portal transactions of LGU-Bulalacao, subject to the following conditions mutually agreed upon by the Parties; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Grant authority to Honorable Mayor Ernilo C. Villas to enter into a Memorandum of Agreement with LandBank of the Philippines to operate LandBank Link Bizportal;


