EARNESTLY REQUESTING THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT (DOH-CHD) MIMAROPA TO FACILITATE THE DEPLOYMENT OF A PHYSICIAN UNDER DOCTOR TO THE BARRIO (DTTB) PROGRAM IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, Article II, Section 15 of the 1987 Philippine Constitution declares that the States shall protect and promote the right to health of the people and instill health consciousness among them;

“WHEREAS, it has been proven in the previous years that rural medical services rendered by the Doctors to the Barrio was of great help in alleviating the health condition of the rural impoverished communities giving them access to various medical needs and services;

“WHEREAS, Bulalacao is a 3rd class municipality hounded with financial constraints which is located at the southernmost tip of the province of Oriental Mindoro, has a population of 44,366 based on 2020 census, has a municipal government that uplift the general health condition of the people;

“WHEREAS, almost 25 percent of Bulalacao's population is composed of Hanunuo Mangyans living in the mountainous area where alarming health hazard such as malaria, filariasis and dengue still exist that needs immediate medical attention to protect these vulnerable group of the community;

"WHEREAS, Bulalacao has only one community hospital with two assigned doctors that can cater immediate medical needs and emergencies to its people, it is located in Barangay Campaasan that is quite far for the communities living in mountains and islands such as in Barangays Benli, San Roque and Maasin,

"WHEREAS, having many Geographically Isolated and Disadvantaged Areas in Bulalacao that for almost 3 years of no assigned rural physician, this Sanggunian is enthusiastically asking the DOH-CHD MIMAROPA to kindly assign a physician under DTTB Program who can give quick and efficient medical services to the necessitous communities living in the barrios; Now, therefore, be it...




