“WHEREAS, Section 2 of Republic Act No. 11037 declares that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being, in recognition of the demonstrated relationship of the demonstrated relationship between food and nutrition, and the capacity of students to develop and learn, the State shall establish a comprehensive national feeding program that will address the problem of undernutrition among Filipino children;

“WHEREAS, malnutrition is the main factor for poor academic performance and contributed to the development of other factors, this imposed a risk factor for high absenteeism, early dropouts, low school enrollment, and unsatisfactory classroom performance which reflect the Philippines that fall below the minimum level of proficiency in reading, mathematics and writing literacy;
