"WHEREAS, Bulalacao is a 3rd class municipality hounded with financial constraints located at the southernmost tip of the Province of Oriental Mindoro, has a population of 44,366 based on 2020 census, and has a municipal government that continues to provide effective health services to its constituents;

"WHEREAS, the Bulalacao Community Hospital is the only hospital in the municipality that can cater immediate medical needs and emergencies to its people;






