"WHEREAS, the cadastral survey of the Municipal Assessment Office of Bulalacao declares the Bangkaso Island as an identified island of Sitio Alimawan, Barangay San Francisco, Bulalacao, hence, NAMRIA issued a certification on March 17, 2022 that this island is considered as Unclassified Public Forest;

"WHEREAS, this Sanggunian understands that Mr. Rannie R. Dablo has a subsisting application for Forest Land Use Agreement for Tourism of the subject property, however, the Local Government Unit of Bulalacao also has an application for this which apparently the CENRO-Roxas did not consider;

"WHEREAS, in consonance with this, the Sangguniang Bayan of Bulalacao has Resolution No. 23-01-012 which was approved on January 20, 2023, the august body had requested the CENRO to allow the LGU of Bulalacao to have a Co-management agreement with DENR in utilizing the Bangkaso Island;









