"WHEREAS, Section 17, of Republic Act No. 7160 otherwise known as the local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as industrial research and development services, as well as the transfer of appropriate technology;

"WHEREAS, Bulalacao is a 3rd class municipality with a vast agricultural land, has 15 barangays and with a total agricultural land area of 10, 325.80 hectares where 6,016 individuals are employed in the agricultural sector;

"WHEREAS, Bulalacao has a tropical climate and is popular in producing large volume of onions where all efforts of diligent farmers are exerted to have these planted every year, these products are being transported to Manila and other provinces;

"WHEREAS, it is ideal and beneficial to have an alternative way or procedure that keeps it shape, color, smell and taste after defrost to a far great extent, hence, the establishment of individual quick frozen processing facility for onions and other crops is a great fitting, which produces a higher quality product and is important for food sustainability, as the consumer can defrost and use the exact quantity needed;

"WHEREAS, the Local Government Unit of Bulalacao is humbly asking His Excellency Ferdinand R. Marcos, Jr., President of the Republic of the Philippines and Secretary of the Department of Agriculture to allocate funds that would fulfill the establishment of this facility and would support to giving better livelihood to the farmers of this municipality; Now, therefore, be it...
