

RESOLUTION NO. 13
ORDINANCE NO. 5

AN ORDINANCE AMENDING RESOLUTION NO. 27, ORDINANCE NO. 10, DATED JUNE 14, 1974, BY INSERTING LETTERS B AND C, PAGE 99 TO 101 OF THE LOCAL TAX CODE WHICH WAS OMITTED IN SAID ORDINANCE NO. 10, HEREOF ENACTED UNDER PD NO. 231, DATED JUNE 28, 1973 BY PD NO. 426 DATED MARCH 30, 1974, IMPOSING MUNICIPAL LICENSE, TAXES, RENTS AND FEES FOR THE EXERCISE OF ALL BUSINESS, OCCUPATION AND PRIVILEGES WITHIN THE MUNICIPALITY AND FOR OTHER PURPOSES.

BE IT Ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in Session Assembled.

SECTION 1. This Ordinance shall be known as the Basic Local Tax Code Ordinance No. 1.

SECTION 2. In Section 7, page 99 to 101 of the Local Tax Code, letters B and C were omitted in Resolution No. 27, Ordinance No. 10 hereof;

SECTION 3. Letters B and C in Section 7, page 99 to 101, of the Local Tax Code is hereby enacted under this Resolution No. 13, Ordinance No. 4 as follows:

B- On cafes, cafeteria, ice cream and other refreshments Parlor, restaurants, soda fountain or food caterers:
