"WHEREAS, Section 1 of Republic Act No. 157 provides that one of the mandated functions of the National Bureau of Investigation (NBI) is to act as a national clearing house of criminal and other information for the benefit of all prosecuting and law enforcement entities of the Philippines; identification records of identifying marks, characteristics, and ownership or possession of all firearms as well as of test bullets fired therefrom;

"WHEREAS, Bulalacao is a 3rd class municipality hounded with financial constraints located at the southernmost tip of the Province of Oriental Mindoro, has a population of 44,366 based on 2020 census, and has a municipal government that preserves the peace and order condition of the people;


"WHEREAS, the issuance of NBI clearance would be of great significance because it is an essential government document that serves as an official police background check and can be used for local as well as foreign employment;




