SPECIAL ORDINANCE NO. 08-10-103

SPECIAL ORDINANCE CREATING A WATER DISTRICT IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO (ALSO KNOWN AS THE BULALACAO WATER DISTRICT PROJECT)

WHEREAS, safe, potable drinking water is essential to human life;

WHEREAS, it is the primary responsibility of the leadership of the Municipality of Bulalacao, Province of Oriental Mindoro to provide the said potable water to its constituents;

WHEREAS, the early delivery of a safe, potable drinking water system would redound to the benefit of the constituents in terms of health and sanitation;

WHEREAS, technical expertise and funds are not readily available within the municipality;


WHEREAS, it is possible to request the assistance of the Local Water Utilities Administration for the creation of a working and viable water district in the Municipality; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Honorable Mayor, Ernilo C. Villas to conduct the following lawful activities:


1. Officially request the assistance of the Local Water Utilities Administration (LWUA) in the creation of a viable Water District in the Municipality;
2. Appoint himself and/or another competent person and/or committee and/or Consultant who shall directly coordinate with the LWUA and assist in the preparation of the requirements including studies and pertinent documents;
3. Conduct other related activities related to the creation of the said Water District including the coordination with technical experts and attendance in technical and financial meetings; and
4. Conduct all lawful and legal actions necessary leading towards the establishment of the Water District; and,
5. Submit to the Sangguniang Bayan of this Municipality for its review and approval prior to its implementation, the results of the technical and financial studies and the final recommendation for the implementation of the Water District Project.

ENACTED this 15th day of October, 2008, Bulalacao, Oriental Mindoro.






