RESOLUTION NO. 1

A RESOLUTION REQUESTING THE HONORABLE PROVINCIAL GOVERNOR THAT THE AMOUNT OF ONE MILLION (P1,000,000.00) PESOS AS ACCUMULATED SAVINGS BY THE PROVINCIAL GOVERNMENT IN THE FORM OF TIME DEPOSIT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) IN CALAPAN BE RELEASED AND BE APPROPRIATED FOR THE MAINTENANCE OF THE ABANDONED ROADS AND BRIDGES OF THE PROVINCE.

WHEREAS, it has been observed by this league that majority of our roads and bridges within the province of Mindoro have never been in good condition since the advent of the present provincial administration;


WHEREAS, this league is fully aware of the existing records, the Provincial Government has accumulated savings in the form of time deposit with the Development Bank of the Philippines in Calapan, in the aggregate amount of one million pesos from the road and bridge fund.

NOW THEREFORE, be it resolved as it is hereby resolved, that the Provincial Governor and the members of the Provincial Board be requested as they are hereby requested that the amount of P1,000,000.00 be released and appropriated to repair and improve the abandoned provincial roads and bridges of this province.
