**SPECIAL ORDINANCE NO. 08-05-69**

**AN ORDINANCE RESERVING THE MUNICIPAL WATERS SURROUNDING THE EXISTING BULALACAO MUNICIPAL FISH LANDING PORT SITUATED AT SITIO KAW-AYAN, BARANGAY POBLACION, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AS RESERVE AREAS FOR FUTURE EXPANSION PROJECT AND DEVELOPMENT OF THE NOW KNOWN AS BULALACAO MUNICIPAL FISH LANDING PORT**

**SPONSOR:** Councilor Gideon B. Abuel

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.

**SECTION 1.** In order to give the Municipal Government of Bulalacao, Bureau of Fisheries and Aquatic Resources (BFAR) and the Philippine Fisheries and Development Authority (PFDA) a valid and subsistent opportunity to upgrade and expand the future development of the now known and established Bulalacao Municipal Fish Landing Port situated at Sitio Kaw-ayan, Barangay Poblacion, Bulalacao, Oriental Mindoro, the municipal waters surrounding the herein mentioned fish port are hereby declared to be reserved areas for future expansion project and development of the Bulalacao Municipal Fish Landing Port;

"The point of reckoning in determining the hereby reserved area shall be the present location occupied by the Municipal Fish Landing Port of Bulalacao which shall include the municipal waters containing an area of one hundred sixty four (164) linear meter by three hundred (300) linear meter on the right portion of the existing Municipal Fish Landing Port of Bulalacao with an area of approximately five (5) hectares and one hundred sixty four (164) linear meter by sixty (60) linear meter of the municipal waters on the left portion of the said Fish Landing Port containing an area of approximately one (1) hectare.";

SEC. 3. This Special Ordinance shall take effect immediately.
