**SPECIAL ORDINANCE NO. 03-03-03**

**AN ORDINANCE DIRECTING THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR TO ASSIST THE MUNICIPAL HEALTH OFFICER TO DRAFT THE LOCAL SANITATION CODE AND SUBMIT THE SAME TO THE SANGGUNIANG BAYAN FOR REVIEW AND APPROVAL**

**"WHEREAS**, it is a Constitutional mandate that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all people at affordable cost;

**"WHEREAS**, pursuant to Section 13, Chapter 3 of the Local Government Code of 1991 and its Implementing Rules and Regulations, the Health Officer shall formulate measures, develop plans and strategies for consideration of the Sanggunian and provide technical assistance and support to the Local Chief Executive in carrying out activities to ensure the delivery of basic services and provision of adequate facilities relative to health services;


**"WHEREAS**, to achieve the abovementioned objective, the Sanggunian passed Resolution No. 98-01-011 directing the Municipal Health Officer to draft the Local Sanitation Code but no avail, so that it is believed that this could be realized now through the assistance of the MPDC; Now, therefore, on motion of Councilor Eduardo C. Acheron duly seconded by all members present;


**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The Municipal Planning and Development Coordinator is hereby directed to assist the Municipal Health Officer to draft the Local Sanitation code and submit the same to the Sangguniang Bayan for review and approval;


**SECTION 2.** This special ordinance shall take effect immediately.


